## HORSE TRAINING & BOARDING AGREEMENT 2024

- **TRAINING FEES & BOARD:** All training and boarding fees of \$1000/mo (+GST) must be paid to the trainer **in full in advance**, prior to each month of training.  
If a horse is pre-booked for 3+ months of training, a reduced rate of \$950/mo (+GST) applies. This discount is not available retroactively.  
Training horses are worked 5 days per week and boarded in individual outdoor pens. Box stalls may be available upon request. Board includes free choice hay (high quality grass and alfalfa available), (un)blanketing and turnout. Any additional feed or supplements are supplied by the Owner.
- **REFUNDS:** A prorated refund is provided, if the trainer sends the horse home prior to expiry of any paid training period (e.g. due to sickness).  
No refund is provided if the owner decides to take the horse home prior to the end of the training month, or prior to finishing any pre-booked contract period. In that case, any money owing on a pre-booked training contract will be charged to the owner's account at the regular monthly rate of \$1000/mo (+GST).
- **DEPOSITS:** a \$250 non-refundable deposit is required to hold a pre-booked training spot.
- **COLT STARTING:** is available on a case by case basis. All 2-yo's need to have any wolf teeth removed and their teeth floated and balanced prior to arriving for training.

- PRIVATE LESSONS are \$40/ea (+GST) while horse is in training. Regular rate is \$65/ea (+GST).
- SALE COMMISSION: If the Trainer is hired by the Owner to act as an agent to market and sell a horse, a 10% commission of the sale price + GST is paid to the Trainer within 7 days of completion of the sale.
- SALE AD, PHOTOS & VIDEO: the fee to create a set of high quality photographs and a video of the horse to be advertised for sale is \$75 + GST (includes editing, uploading to Youtube, creating and posting of the sale ad on various online platforms).
- OTHER SERVICES: Veterinary, farrier and other special services are **not** included in the training or boarding fees. Farrier, chiropractic and massage services etc. can be arranged for if required or requested, with the Owner's consent. Any such cost needs to be paid for in full within 7 days.  
 Veterinary services will be secured if deemed necessary by the Trainer in case the Owner cannot be reached within a reasonable time frame. All expenses incurred are the Owner's responsibility and need to be paid for in full within 7 days.

# RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

The Owner agrees as follows:

1. TO WAIVE ANY AND ALL CLAIMS against a Property Owner or the Trainer and their directors, officers, employees, agents representatives and volunteers (all of whom are hereinafter collectively referred to as "THE RELEASEES") and to RELEASE THE RELEASEES from any and all liability for any loss, damage or injury the above mentioned training horse may suffer while in care and custody of the Trainer, and any and all expenses incurred with this loss, damage or injury. This INCLUDES NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OR CARE INCLUDING ANY DUTY OF CARE OWED UNDER THE "OCCUPIERS LIABILITY ACT" ON THE PART OF THE RELEASEES.
2. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES from any and all liability for any damages to the property of or personal injury to any third party while in care and custody of the Trainer.
3. **THE OWNER IS ADVISED TO OBTAIN A MORTALITY & LIABILITY INSURANCE POLICY FOR ANY HORSE BOARDED AT THE TRAINER'S FACILITY.**
4. This agreement shall be governed by and interpreted in accordance with the laws of the Province of Saskatchewan.
5. Any litigation involving the parties to this Agreement shall be brought within the Province of Saskatchewan.
